REBATES AND INCENTIVES

Appliances and Home

- \$75 rebate for Energy Star freezer and/or refrigerator with recycling of old unit (recycling receipt required)
- \$50 rebate for recycling a freezer or refrigerator (recycling receipt required)
- \$25 rebate for Energy Star electric clothes dryer or washer
- \$25 rebate for Energy Star dehumidifier
- \$50 rebate for a battery powered yard tool: lawn mower or snowblower
- \$25 rebate for purchase of an Energy Star new freezer or refrigerator
- \$25 rebate for installing WiFi smart thermostat
- \$5 rebate for an engine block heater timer
- \$25 rebate for a battery powered yard or sport tool: trimmer, leaf blower, chain saw or ice auger

Heating and Cooling

- **Ducted Air Source Heat Pump: Qualified Installers (metered cycle AC and dual fuel)**
 - \$750 rebate for installing* <5-tons, >14.3 SEER2 & >7.5 HSPF2 air source heat pump
 - \$1,000 rebate for installing* <5tons, 2025 CEE Tier 1 Listed air source heat pump**

*Q: Must be installed by a contractor certified by Great River Energy.

- **Ductless Air Source Heat Pump**
 - \$500 rebate for installing Energy Star ductless air source heat pumps for primary heat with delivered fuels
 - \$500 rebate for installing Energy Star ductless air source heat pumps with primary (hard-wired) electric heat
 - \$500 rebate for installing a ductless ASHP (AHRI certificate required) – with primary (hard wired) electric heat >1 ton >14.3 SEER2 & >7.5 HSPF2 >1 ton, 2025 CEE Tier 1 Listed
 - \$500 rebate for installing a ductless ASHP (AHRI certificate required) – primary heat is fossil fuel >1 ton >14.3 SEER2 & >7.5 HSPF2 >1 ton, 2025 CEE Tier 1 Listed

**Products must be CEE Tier 1 Listed www.cee1.org. CEE Tier listing must be confirmed via AHRI directory of certified products at www.ahridirectory.org.

- **Ground Source Heat Pumps (dual fuel or general service)**
 - \$400 per ton rebate for residential ground source heat pumps (must be installed by a certified HVAC contractor, and must be confirmed by an LCP technician with a picture of the name plate)
- **Electric Thermal Storage (ETS) Heat (off-peak)**
 - \$50 per KW rebate for an installed Steffes room unit or furnace, metered off-peak (Steffes™ room units, furnace or hydronic system must be purchased new from LCP)
- **Cooling (Central Air Conditioning)**
 - \$100 rebate for cycled AC* (CAC). CAC Must be SEER 2 rated www.seer2.com (rebate for new or existing systems, not qualifying for any other listed rebate; separate meter required)

Water Heating (Off-Peak or 8-Hour Interruptible)

- \$600 rebate for installing, converting from fossil fuel, or upgrading/replacing existing to Rheem Marathon® off-peak water heater (must have .90 energy factor or greater; 100-gallon capacity; purchased from LCP)
- \$500 rebate for heat pump water heater, Energy Star rated
- \$200 rebate for installing, converting from fossil fuel, or upgrading/replacing an existing water heater that is on or being added to the 8-hour interruptible water heating program (must be a minimum of 50-gallon capacity and be purchased from LCP)

Residential Lighting

- \$0.50 per bulb (minimum 4 screw-in bulbs needed for submitting paperwork, must be Energy Star rated LED)
- \$2 per Energy Star holiday LED light strings
- \$30 per installed Energy Star LED yard light (not installed by LCP)

Electric Vehicle Charging: ChargeWise

- Up to a \$500 rebate* for installing a Level 2 hardwired charger. Installation requires a contractor-installed contactor.**
- Up to a \$500 rebate* for purchasing and installing a Level 2 hardwired charger purchased through Enphase, www.enphase.com.

*Chargers must be metered on off-peak for electric vehicle charging.
