

EIP Grant Helps Lincoln Build Accessible Playground

In November 2023, the Lincoln Middle School Parent Teacher Organization had money to spare and a playground more than 20 years old. So, they decided to fundraise for a new one.

Fast-forward to August 2025, and the Hibbing school cut the ribbon on the \$660,000 project that expanded the playground size and made way for adaptive equipment so kids with differing needs could be included.

"We've added ramps to just get on the equipment, there's a teetertotter that can fit a wheelchair or walker, there's benches," said Jessica Whitney, one of the PTO project leaders. "There's sensory equipment like tracing boards, communication boards, sign language boards and things like that."

A light rain didn't dampen the opening day as kids raced down the ropes, down the slides and explored the new space. Whitney and Kayla Hintz, the other co-leader on the project, cut the ribbon to officially mark the opening, just weeks before the start of classes.

"This isn't just any playground, it's a space with designs that every single student, no matter their ability, can play, explore and belong," said Lincoln Principal Derek Gabardi. "That's what this playground stands for — play hard, laugh loud and always look out for one another."

The Lincoln PTO, through an application from Hibbing School District #701, received \$60,000 last year from Lake Country Power, through the Education Improvement Program (EIP) grant, to help fund the project.

EIP grants utilize "unclaimed capital credit" funds for awards up to \$100,000. The State of Minnesota allows electric cooperatives, like LCP, to keep the monies local and use them toward educational purposes after members' refunds go unclaimed for a number of years. These funds **cannot** be used for operational purposes or anything else that doesn't meet State statute.

The application period opens September 1, 2025, and closes November 30, 2025. This year LCP is launching a new application system through the company Kaleidoscope. Schools submitting applications should make sure emails from "mykaleidoscope.com" are whitelisted and do not get flagged as spam.

Lake Country Power has granted more than a million dollars since the EIP's initial year in 2023. The program follows the Seventh Cooperative Principle of concern for community, which emphasizes the strengthening and development of local communities surrounding LCP membership.

Seasonal Weatherization Tips to Save Energy Year-Round

Whether you're looking ahead to prepare for colder months or want to learn how to increase your energy savings throughout the year, weatherizing your home for each season is a great way to save energy and stay comfortable all year long.

About 30% or more of your home's heat loss in cooler months is due to air infiltration or air change per hour. The higher the air change per hour will equate to your home's dryness and low humidity. Ask yourself if you require a humidifier during the winter months that requires filling every day to stay comfortable.

Before joining the Lake Country Power board, I worked for the co-op for 30 years doing energy management. Here are a few things you can do now, during the warm months, to prepare your home for the heating season.

- Insulate exterior-facing wall outlets/light switches. I prefer foam outlet covers/gaskets. These are easy to install.
- Keep your windows closed and locked. The lock is more to assure a good gasket seal between the window and the frame.
- Seal drafts with weather stripping or caulk. Doing this can
 prevent drafts and save you about 5%-10% on your energy
 costs. Start outside by checking around the windows and
 doors for cracks or voids in the existing caulk. Remove the
 old caulk if possible and install new caulk. Use a highquality caulk suitable for material you are sealing such as
 silicone, latex or acrylic. Also, replace old door weather
 stripping for a tight seal.

- Check your door sweeps. Do you put a rug in front of the door during the winter to stop the cold air and the rug freezes to the door? A quality door sweep, weather stripping and caulking the trim both inside and out is important.
- Is your clothes dryer vent sealed properly? Check inside/ outside to make sure the pipe is caulked/sealed.
- Important contact your local heating contractor and get on the list to have your furnace system checked out before the heating season and stock up on furnace filters. Don't wait until you need the heat to see if your heating system is working properly.

These are just a few of the recommendations I've made when performing energy audits.

Cold Weather Rule Effective October 1

The Cold Weather Rule, Section 216B.097 of the Minnesota State Statutes, provides that from October 1 through April 30 an electric cooperative cannot disconnect a residential customer for nonpayment of service, if the disconnect affects the primary heat source and all of the following conditions are met:

- The customer declares an inability to pay and completes the Inability to Pay form;
 and
- 2. Household income of the customer is at or below 50 percent of the state median income. Income may be verified on forms provided by LCP or by the local energy assistance provider with whom the customer has applied for energy assistance; and
- The customer enters into and makes reasonably and timely payments under a mutually agreeable payment plan, that considers the financial resources of the household: and
- 4. A customer receives from LCP referrals to energy assistance, weatherization, conservation, or other programs likely to reduce the customer's energy bills.

The law does allow for LCP to disconnect when it is necessary from October 1 to April 30, so please act promptly. LCP works with members during the Cold Weather Rule period, just as we do throughout the year. We don't want to interrupt service to any member, but in a cooperative, all members suffer when any bill remains unpaid. If bills remain unpaid, this amount must be absorbed by members who faithfully pay their bill each month. LCP would rather work with members to establish and maintain adequate payment schedules of their past due bill. A statement explaining the payment plan to secure continued service, a Payment Arrangement letter, will be provided.

Before disconnecting service to a residential customer from October 1 to April 30, the cooperative must provide the following information:

- notice of proposed disconnection (disconnection notice); and
- statement explaining customer's rights and responsibilities (Inability to Pay form);
- list of energy assistance providers (Inability to Pay form); and
- forms available for customer to request cold weather disconnect protection (Inability to Pay form).

If you receive a disconnection notice this winter, you must act promptly. If you do not meet all the conditions of the Cold Weather Rule, mutually acceptable payment arrangements can be set up to prevent interruption of an electric service. Lake Country Power's 2025 Youth Tour Delegate Shares Her Story

Lake Country Power sponsored Tegan Fordahl from South Ridge School, Culver, Minn., to attend the Electric Cooperative Youth Tour in Washington, D.C., in June. This Q&A with Tegan reflects on her experience and is condensed for space. The full interview can be found at www.lakecountrypower.coop.

Youth Tour brings together nearly 2,000 students nationally and has a legacy stretching back decades. How did it feel being part of such a longstanding tradition? Being a part of this tour was such a fantastic experience. Our group got to experience many things that would never have been possible if we had not been a part of the Youth Tour, and I think that makes it even more special. I know that I will always look back on this trip with fond memories, and I am so incredibly thankful to have been chosen to participate in this tradition.

How will your Youth Tour experience influence your goals, especially as you are thinking about careers and colleges?

Since I was a little girl, my goal has been to become a lawyer. This trip solidified that for me. Experiencing Washington, D.C. helped me gain an even broader understanding of our nation's government, and has inspired me to one day pursue a position in our government, alongside a career in law.

What is one insight or piece of knowledge from the trip you wish you could share with your classmates back home? If I could give one piece of insight to my classmates back home – and everyone, really – it would be to work together. We tend to be so divided from each other, but if we could focus more on collaboration than disunion, we could accomplish so much more. Although there is still division in government, collaboration is such an essential part of our nation's capital.

What are some of the biggest takeaways or highlights you have from the trip? One of the highlights of this trip was the architecture I was able to see. I've always been a bit of a nerd when it comes to architecture and history, so being able to explore some of the oldest and most influential buildings and monuments in our nation was such an amazing opportunity.



What was your favorite part of the trip? One of my favorite parts of our trip was meeting our senators, Tina Smith and Amy Klobuchar. Being able to speak with such influential people was such a thrilling experience. Even from the short conversations our group had with both women, you could feel their dedication. This experience was a significant factor in inspiring me to pursue a position in our government, as well.

Did you make any connections—friends or mentors—that you think will continue beyond this summer? During this trip, I met four girls with whom I connected instantly. The bond we formed in our week in D.C. is one I haven't experienced in ages, and I know we will stay in contact long after our teenage years.

How did the sessions focusing on co-ops and energy influence your understanding of the co-op model? The co-op-focused sessions we attended greatly deepened my understanding of co-ops. They were engaging and entertaining, and gave me a great sense of what makes a co-op tick. I wasn't well-versed in co-ops before my trip, but I can now safely say that I have a great understanding of and deep respect for the co-ops of our nation.

What advice would you give to other students thinking of applying for the Youth Tour in the future? My biggest piece of advice for anyone thinking about applying is plain and simple: just apply! If you don't think it will pertain to the path you want to take later in life, I promise you will find some pocket of the trip that does. If you're scared of being away from home, the people you meet on your trip will make you forget you're even in a different state. And most importantly, if you have any questions, find someone who has been on the trip! I did exactly that, and it was so helpful to have someone who had already been through the process to help me out.

Cooperative Heroes Award celebrates Minnesota's cooperative values – integrity, innovation, reliability, accountability and commitment to community. Judges will carefully evaluate each application and nominee for these qualities as they select three outstanding winners in Minnesota.

Each winner will receive funding to support a local nonprofit or good cause of their choice. First place receives \$1,000; second and third place receives \$500 each.

Almond Bars

Crust:

1 c. butter, room temp. 2 c. flour

½ c. powdered sugar

Filling:

8 oz. cream cheese – room temp.

2 eggs

½ c. sugar

1 T. almond extract

Frostina:

1 ½ c. powder sugar ¼ c. butter, room temp.

1 ½ T. milk

1 T. almond extract

DIRECTIONS:

Preheat oven to 350 degrees F. Grease 9x13 pan. Mix crust ingredients until smooth and then press into 9x13 pan. Bake 20 to 25 minutes. While crust is baking beat filling ingredients until smooth. Pour over baked crust while still hot. Place pan back in oven and bake for an additional 15 to 20 minutes. Cool completely. In a mixing bowl, combine all ingredients for frosting and beat until smooth. Spread over bars after they have cooled. Store in an airtight container.
