REBATES AND INCENTIVES

Appliances and Home

- \$25 rebate for Energy Star freezer and/or refrigerator with recycling of old unit (recycling receipt required)
- \$25 rebate for freezer or refrigerator recycling only (recycling receipt required)
- \$25 rebate for Energy Star clothes dryer
- \$25 rebate for Energy Star dehumidifier

Heating and Cooling

- **Ducted Air Source Heat Pump: Qualified Installers (metered cycle AC and dual fuel)**
 - \$1,250 rebate for installing QI Seer 18 air source heat pumps*
 - \$1,000 rebate for installing QI Seer 17 air source heat pumps*
 - \$630 rebate for installing QI Seer 16 air source heat pumps*
 - \$580 rebate for installing QI Seer 15 air source heat pumps*
 - \$480 rebate for installing QI Seer 14.5 air source heat pumps*
 - *QI: Must be installed by a Great River Energy and LCP certified HVAC contractor. Must be metered dual fuel.
- **Ductless Air Source Heat Pump**
 - \$300 rebate for installing Energy Star ductless air source heat pumps for primary heat with delivered fuels
 - \$500 rebate for installing Energy Star ductless air source heat pumps when primary (hard-wired) electric heat
 - \$200 additional ductless air source heat pumps when metered on cycled air conditioning/dual fuel (must have auto restart control)

- **Cooling (Central Air Conditioning)**
 - \$100 rebate for cycled air conditioning
- **Ground Source Heat Pumps (dual fuel or general service)**
 - \$400 per ton rebate for residential ground source heat pumps (must be installed by a HVAC contractor)
- **Electric Thermal Storage (ETS) Heat (off-peak)**
 - \$50 per KW rebate for installed metered off-peak (Steffes™ room unit(s), furnace or hydronic system)
- **Miscellaneous**
 - \$25 rebate for ECM furnace motor
 - \$25 rebate for installing WiFi smart thermostat

Water Heating (Off-Peak or 8-Hour Interruptible)

- \$600 rebate for installing, converting from fossil fuel, or upgrading/replacing existing to Rheem Marathon® off-peak water heater (must have .90 energy factor or greater; 100-gallon capacity)
- \$500 rebate for heat pump water heater
- \$200 rebate for installing 8-hour interruptible water heating and converting from fossil fuel (50+ gallons)
- \$100 rebate for installing 8-hour interruptible water heating to existing electric water heater (50+ gallons)
- \$50 rebate for converting 4-hour peak shave water heating to 8-hour interruptible water heating

Residential Lighting

- \$2 per Energy Star rated LED, limit 10 per member, per year. (receipt copy and packaging showing Energy Star logo/quantity of bulbs required)**
- \$1 per Energy Star holiday LED light strings**
- \$30 per installed LED yard light**

Electric Vehicle Charging: ChargeWise

- \$500 rebate for installing an electric vehicle with a Level 2 charger; metered on off-peak

* Must be installed by a Great River Energy certified HVAC contractor.
