Minnesota Energy Loan

The Neighborhood Energy Connection has partnered with the Minnesota Housing Financing Agency to bring Minnesotans a new way to finance energy improvements to their homes. It's called the Minnesota Energy Loan.

To participate, a homeowner obtains a Home Energy Audit and completes at least one of the auditor's recommended home energy improvements. These home improvements save energy and reduce the homeowner's utility costs.

By doing at least one home energy improvement, the homeowner can also finance any other home improvements at the same low rate. Other improvements may include kitchen or bath remodels, window or door replacement, new flooring, roofing and nearly any home improvement the homeowner wishes to make.

The Minnesota Energy Loan is available at a **6.25% fixed rate**, with minimal closing fees. Below is a quick overview of the guidelines of the program.

- Minimum loan amount \$2,000, maximum \$35,000
- Maximum upper income limit of \$93,100 gross household income
- All loans are secured by a mortgage so the interest is tax deductible
- One-day approval with closings through the mail is offered
